Thank you for your letter dated 29 November 2011 where you informed me on the proposal of the Polish Presidency with respect to the next steps in parliamentary scrutiny of CFSP and CSDP.

I would like to inform you that I forwarded all the materials for discussion to the specialized committees of the Chamber of Deputies of the Parliament of the Czech Republic - namely the Foreign Affairs Committee, the European Affairs Committee and the Defense Committee. The Foreign Affairs Committee and the European Affairs Committee adopted resolutions, which are attached to this letter. The Defense Committee could not meet to discuss the draft of the Polish presidency and thus the Committee only accepted an opinion of the chairman and vice-chairmen, where they refer to the Committee's resolution on the issue adopted in March 2011.

The Committees in their decision took account of current developments regarding CFSP / CSDP and their opinion will be the basis for the position, that the Chamber of Deputies will defend in further negotiations on this issue.

Resolutions of the specialized committees will also be the basis for my mandate, as the Speaker of the Lower House of the Parliament of the Czech Republic, for the next Conference of the Speakers of Parliaments of the EU in April 2012 in Warsaw, where the question of CFSP and CSDP will be discussed.

In that Resolution, the Committee expressed its conviction that the European Parliament should be represented at the Inter-Parliamentary Conference, which supervises the Common Foreign and Security Policy and Common Security and Defence Policy, with the equal number of delegates as the national parliaments of EU member states, i.e. 6 delegates, especially with regard to the ongoing intergovernmental nature of co-operation in this field.
- 3. expresses its surprise that the numbers of delegates of national parliaments and the European Parliament were agreed based on the consultation of the Polish Presidency and the European Parliament without the knowledge of national parliaments. The European Affairs Committee hopes that the conclusions of the Conference of Speakers of National Parliaments held in April this year will be respected, according to which the agenda shall be set by the presiding country, which shall also preside over the conference, and the conference shall decide by consensus, i.e. each delegation de facto has a veto right.
- 4. instructs the chairman of the Committee to inform Madam Speaker of the Chamber of Deputies on this Resolution.
