## **The Committee**

#### I. Adopts

a recommendation

- on the Proposal for a Regulation of the European Parliament and of the Council establishing an Entry/Exit System (EES) to register entry and exit data of third country nationals crossing the external borders of the Member States of the European Union;
- on the Proposal for a Regulation of the European Parliament and of the Council establishing a Registered Traveller Programme;
- on the Proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 562/2006 as regards the use of the Entry/Exit System (EES) and the Registered Traveller Programme (RTP),

# II. Recommends

that the Senate of the Parliament of the Czech Republic give a statement

 on the Proposal for a Regulation of the European Parliament and of the Council establishing an Entry/Exit System (EES) to register entry and exit data of third country nationals crossing the external borders of the Member States of the European Union;

- on the Proposal for a Regulation of the European Parliament and of the Council establishing a Registered Traveller Programme;
- on the Proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 562/2006 as regards the use of the Entry/Exit System (EES) and the Registered Traveller Programme (RTP),

in accordance with the recommendation adopted by the Committee;

Senator Tomáš Grulich the Committee's rapporteur at the plenary session of the Senate of the Parliament of the Czech Republic;

#### Recommendation to the Senate of the Parliament of the Czech Republic

on the Proposal for a Regulation of the European Parliament and of the Council establishing an Entry/Exit System (EES) to register entry and exit data of third country nationals crossing the external borders of the Member States of the European Union

on the Proposal for a Regulation of the European Parliament and of the Council establishing a Registered Traveller Programme

on the Proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 562/2006 as regards the use of the Entry/Exit System (EES) and the Registered Traveller Programme (RTP)

The Senate of the Parliament of the Czech Republic

#### I.

#### Has acquainted itself

with the proposed legal acts introducing the "smart borders system" and appreciates the effort of the Commission to strengthen the security on the EU's external borders;

# II.

#### 1. Endorses

the establishment of an Entry/Exit System (EES), its role in the fight against illegal migration, especially in the framework of reducing the risk of identity fraud and manipulation with travel documents, and facilitation of information sharing among Member States;

#### 2. Deems

it important that the verification of fingerprints in the EES has a systematic nature and is carried out at every crossing of the external border;

#### 3. Points out

the potentially limited contribution of a Registered Traveller Programme (RTP) to the protection of borders, and the fact that the initiative is due to this limited contribution disproportionately costly;

# 4. Is of the opinion

that lodging applications for access to the RTP should only be allowed in the territory of Member States;

## 5. Considers

useful to ensure an access on individual basis to both of the proposed systems (EES, RTP) to law enforcement authorities;

#### III.

# 1. Requests

the Government to inform the Senate about the way this position was taken into account and to provide the Senate with information on the further proceeding of negotiations;

#### 2. Authorises

the President of the Senate to forward this Resolution to the European Commission.
