ANNEX I

NEW VESSELS < 15 METRES OVERALL LENGTH

The gross tonnage of new fishing vessels of overall length less than 15 metres is defined as:

$$GT = K_1 \cdot V$$

where: $K_1 = 0,2 + 0,02 \log_{10} V$

and V is the volume, given by:

$$V = a_1 (L_{oa} \cdot B_1 \cdot T_1)$$

where:

L_{oa} = length overall (Article 2 of ~~⊗~~ this ~~⊗~~ Regulation)

B_1 = breadth in metres according to the 1969 Convention

T_1 = depth in metres according to the 1969 Convention

a_1 = a function of L_{oa}

VESSELS < 15 METRES OVERALL LENGTH EXISTING ~~⊗~~ ON 1 JANUARY 1995 ~~⊗~~

The gross tonnage of fishing vessels existing ~~⊗~~ on 1 January 1995 ~~⊗~~ of overall length less than 15 metres is defined as:

$$GT = K_1 \cdot V$$

where V is volume, given by:

$$V = a_2 (L_{oa} \cdot B_1 \cdot T_1)$$

where:

~~⊗~~ L_{oa} = length overall (Article 2 of this Regulation) ~~⊗~~

B_1 = breadth in metres

T_1 = depth in metres

a_2 = a function of L_{oa}

The functions a_1 ~~⊗~~ and ~~⊗~~ a_2 ~~⊗~~ shall ~~⊗~~ be fixed on the basis of statistical analyses of pooled representative samples of the fleets of the Member States. These ~~⊗~~ shall ~~⊗~~ be specified together with definitions of the dimensions B_1 and T_1 and with detailed rules for the application of the formulae in a Decision of the Commission ~~⊗~~¹ ~~⊗~~.
