Cover letter for Christiana Fryda

Dear Chairman,

With this letter I would like to express interest in applying for the post of permanent member of the COSAC secretariat and present my motivations for this application.

My professional experience in European Affairs commenced in 2001, prior to Cyprus' accession to the EU, when I was employed by the House of Representatives of Cyprus, as part of the then newly established European Affairs' Service consisting of a group of young lawyers specialised in EU law, to work in the field of harmonisation of national legislation with the acquis communautaire and to support members in the House's activities involving EU affairs. It is in this context, through preparing members, that I first got acquainted with the proceedings, the agendas, the rules of procedure, the biannual reports, but also the substance and vision of COSAC as a platform for interparliamentary cooperation. My knowledge of the functioning of COSAC has been further developing since 2007 when I was posted as a permanent representative of the House to the European Parliament in Brussels. Since then I have been able to deepen my understanding of the dynamics of COSAC through a constructive exchange of views with colleagues from other national parliaments and the European Parliament.

My relationship with COSAC was more enhanced when the House of Representatives engaged in preparing the parliamentary dimension of the Cyprus' Presidency of the Council of the European Union. Working for the Presidency and assisting the House as its representative in Brussels gave me the opportunity to experience both the practical aspect of the organisation of COSAC and its substantive aspect from the inside. Being a member of the COSAC secretariat itself for a year and a half (1 January 2012 and 1 July 2013) enabled me to cooperate with officials from the troika, under the coordination of the permanent member, both as a member of the secretariat assisting Presidency parliaments and as a member representing a Presidency parliament. It is my view that this experience, along with my ability to work well both in English and in French, would contribute to a great extent to the effective functioning of the secretariat.

Both my skills acquired through my academic education and my skills and understanding acquired through my multi-faceted professional experience may prove very useful for the post. My legal background has provided me with the necessary drafting skills, skills in analysing and processing information and a keen analytical eye for detail. It has moreover provided me with the ability to work efficiently under pressure on thesis, antithesis and 'grey areas' and, in this context, to facilitate synthesis of ideas and views. My professional experience in interparliamentary affairs all these years in the House of Representatives in Nicosia, and especially in Brussels, has enhanced my understanding of the workings of other national parliaments and the European Parliament. What is more, it has strengthened my interpersonal relations and my ability to work in a changing multi-cultural environment. In addition, the task of establishing an office representing the House at the European Parliament from scratch entrusted to me, as one of the first two employees of the House in Brussels, has not only improved my organisational and managerial skills, but has also promoted my ability to find innovative effective working methods at the workplace. Last, but not least, my background enhanced by a literary element has encouraged me to approach my work as a challenging project and the workplace as a creative space, where development of ideas could potentially be envisaged and implemented.

The challenges entailed in assisting the functioning of an important forum such as COSAC aiming to promote the exchange of information and best practice between national parliaments and the European Parliament would, at the same time, deepen my own understanding of interparliamentary cooperation and provide a stimulating working environment for me.

In the light of the above, I believe that my skills and experience, if I were successful in this application for the post of permanent member of the COSAC secretariat, would provide the secretariat with the support needed to successfully fulfil its tasks.
