Dear Madam President,

Recent decisions and agreements reached in order to restore the financial stability of the Euro area have risen up concerns as regards to the parliamentary control of the Eurozone. I think the present situation could present some danger.

The European Union of 27 members is already under a full parliamentary control thanks to the important powers granted to the European Parliament and the increasing association of national parliaments. However, the center of decision-making is now slightly moving towards the meetings of the Euro area or those of other forms of intergovernmental cooperation, where only the Governments are represented. Parliaments are gradually put on the sidelines.

I believe COSAC would be an excellent place for discussing how we could improve democratic control and for taking an initiative on this issue. Therefore, I would very much appreciate if you accepted to put this question on the agenda of the next COSAC meeting, which will take place in Copenhagen.

Should you wish to discuss this idea with me, please do not hesitate to contact me. I look forward to seeing you in Copenhagen in a few weeks.
