Droposed amendments to draft Con

Proposed amendments to draft Contribution and Conclusions of the XLV COSAC

Thank you for circulating the draft Contribution and Conclusions ahead of the COSAC meeting in Budapest next week.

I would like to suggest three amendments to the text of the contribution and two amendments to the conclusions, which I hope that you and our other colleagues will find acceptable. This covering letter introduces and explains the amendments and for clarity I have set out the textual changes in the attached table.

I. PROPOSED AMENDMENTS TO THE DRAFT CONTRIBUTION

Amendment one

In paragraph 1.3, line four, after "parliamentary involvement" insert "including through their scrutiny of national reform programmes".

My proposal would mean that that paragraph 1.3, which discusses Parliamentary involvement in the European Semester, would include reference to national reform programmes.

Amendments two and three

In paragraph 2.1, line three, delete "with satisfaction".

In the same paragraph, line seven, at the end insert the following new sentence "We look forward to a new meeting to continue this scrutiny work being convened at the earliest opportunity."

Amendments two and three make it clear that, notwithstanding the important progress made at the last Speakers' Conference, the issue of the future scrutiny of CFSP and CSDP still needs to be resolved.

2. PROPOSED AMENDMENTS TO THE DRAFT CONCLUSION

Amendments four and five

In paragraph 4, line one, after "hold", insert ", at the Presidency's discretion,".

In paragraph 5, line three, after "place", insert ", at the Presidency's discretion,".

My proposal would mean that should for any reason a Presidency parliament decide not to hold a general policy debate on the Commission's work programme, it would not be bound so to do. I believe this change would provide helpful flexibility for the setting of future agendas.

I look forward to seeing you again in Budapest, for what promises to be a very productive COSAC meeting.
