




1. Are you familiar with the IPEX Digital Strategy?




2. Are you familiar with the IPEX Work Programme 2017 - 2020?



3. Do you have the "IPEX Correspondent" tasks added to your job description?




4. Are you sending any information related to your activity as an IPEX national Correspondent, to your Parliament's Permanent Representative in Brussels?

- To strengthen their role, generally it could be helpful for correspondents, if they have more awareness of IPEX through a higher density of interaction within the group of the NC's.


6. What kind of activities or tools might help to encourage communication and exchange of information between IPEX national Correspondents?

- Skype for business;
- Annual correspondent meetings;
- Current tools are sufficient for the communication and exchange of information between the IPEX national Correspondents.




8. If you have any other ideas on how to improve the NCM, please share it with us!

- Thematic discussions not necessarily linked to IPEX itself like strengthening subsidiarity procedures and activities or rights of the NPs in EU-Affairs
- Presentation of an yearly report; working group on 2019 Annual Work Programme; working group on Parliamentary Dimension of the current and upcoming Presidency of the Council of the EU.
- The participation of the main target group, as pointed out in the digital strategy, especially members of the parliaments and their assistants and employees of the political groups, could help to generate a higher diversity of opinions and of course to hear the view from outside. It also could help to strengthen the role of the NC's within their parliaments/chambers.
- Trainings only for new Correspondents, opened for interested "old" ones and for everyone in case of important changes on the website


9. Was the IPEX leaflet translated in your Parliament/into your own language?



10. Have you organized any IPEX presentation or training in your Parliament, in the past 12 months?




11. In your opinion, which structure within your Parliament would mostly benefit from an IPEX training or presentation




11. In your opinion, which structure within your Parliament would mostly benefit from an IPEX training or presentation. Other

- Civil servants, assistants of MPs and political groups.


12. Do share information about new items on IPEX with your ECPRD correspondents?




13. Do you think that information requests submitted by your own ECPRD correspondent should be shared?



14. Do you think that a shared list (weekly/monthly) of ECPRD requests would be good?




15. Do you interact with other external actors from the field of parliamentary cooperation?




