Following introductory information from Mr Michal Sedláček, Deputy Minister of European Affairs, the rapporteur's report by Senator Luděk Sefzig and after a debate

#### the Committee

#### I. Takes into account

the Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions - Commission Work Programme 2010 Time to act;

#### II. Recommends

to the Presidency of the Conference of Community and European Affairs Committees of Parliaments of the European Union (COSAC) to continue with its established practice of the coordinated testing of adherence to the principle of subsidiarity, and, in so doing, to consider submitting of the following EU legislative proposals to the future coordinated check:

- Revision of Regulation (EC) No 44/2001 on jurisdiction, recognition and enforcement of judgments in civil and commercial matters (Brussels I)
- Revision of the Working Time Directive
- New comprehensive legal framework for data protection
- Possible Commission initiative to step up beyond 20 % (20 to 30 %)
- Proposal for a revision of existing legislation to integrate mitigation and adaptation
- Legislative proposals concerning reconciliation of family and work life
- Proposal for a Directive on the conditions of entry and residence of thirdcountry nationals for the purposes of seasonal employment
- Proposal of a new legal framework on the recovery of assets
- Proposal for a review of Directive 2006/24/EC (Data Retention)
- Proposal for modification of Directive 2003/86/EC on the right to family reunification
- Proposal for a Regulation on the conflicts of laws in matters concerning

matrimonial property rights, including the question of jurisdiction and mutual recognition, and for Regulation on the property consequences of the separation of couples from other types of unions

 Legislative proposal on a comprehensive regime on obtaining evidence in criminal matters based on the principle of mutual recognition and covering

all types of evidence

 Legislative proposal to introduce common standards for gathering evidence in criminal matters in order to ensure its admissibility

- Legislative proposal on Legal Advice and Legal Aid

 Legislative proposal for a Common Consolidated Corporate Tax Base (CCCTB)

#### III. Authorises

the Committee Chairperson Senator Luděk Sefzig to submit this resolution to the President of the Senate and to the Presidency of the Conference of Community and European Affairs Committees of Parliaments of the European Union (COSAC).
