Interim update on COSAC subsidiarity checks

Based on the proposals from national parliaments, the COSAC Chairpersons in their meeting on 18 February 2008 in Ljubljana agreed to carry out subsidiarity checks on the following two legislative proposals:

- Proposal for a Regulation of the European Parliament and of the Council on the applicable law, jurisdiction, recognition of decisions and administrative measures in the area of successions and wills (2008/JLS/122); and
- Proposal for a Directive implementing the principle of equal treatment outside employment (2008/EMPL/017)¹.

This decision was confirmed in the Conclusions of the XXXIX COSAC that took place on 7-8 May 2008 in Brdo pri Kranju².

The Proposal for a Council Directive implementing the principle of equal treatment between persons irrespective of religion or belief, disability, age or sexual orientation instead of June 2008 was adopted on 2 July 2008 (during the French Presidency, rather than during the Slovenian Presidency as expected at the XXXIX COSAC meeting).

Following the adoption of the Proposal for a Council Directive implementing the principle of equal treatment between persons irrespective of religion or belief, disability, age or sexual orientation, the COSAC Secretariat has prepared necessary arrangements for the subsidiarity check, which will be conducted by national parliaments within the eight weeks after the Proposal is made available in all official languages of the EU. The Commission has informed the COSAC Secretariat that all linguistic versions of this proposal will be made available in the second half of July 2008.

According to the information provided by the Commission, the original date for the adoption by the Commission of the Proposal for a Regulation of the European Parliament and of the Council on the applicable law, jurisdiction, recognition of decisions and administrative measures in the area of successions and wills has changed. This Proposal **will now be adopted in the 1st quarter of 2009** rather than in November 2008.

Since the Proposal for a Regulation of the European Parliament and of the Council on the applicable law, jurisdiction, recognition of decisions and administrative measures in the area of successions and wills will not be adopted until 2009, the COSAC Chairpersons will have to decide whether to conduct a second subsidiarity check in 2008. If they decide to do so they will need to decide on which Proposal.

Below is the table of the suggestions from national parliaments which was discussed at the COSAC Chairpersons meeting in Ljubljana, together with updated information on the estimated date of adoption of the Proposals.
