It is my pleasure to inform you that the Conference of European Integration Parliamentary Committees of Countries participating in the Stabilization and Association Process of South-East Europe was held on 17 and 18 June 2005 in Sarajevo, in accordance with the reccommendations from the European Union Summit, held in Thesalloniki in June 2003.

It was the first meeting of the Committees, where the Conference of Parliamentary Committees for European Integration / Affairs of the countries participating in the Stabilization and Association Process – Albania, Bosnia and Herzegovina, Croatia, Macedonia, Serbia and Montenegro – COSAP was established as a body for cooperation and exchange of views concerning the Stabilization and Association Process, EU membership agenda of the countries in the Process and the EU enlargement process.

At this first meeting we adopted the Rules of Procedure of our Conference – COSAP, as a framework for future work and cooperation.

It was a pleasure for me to hear that the parliaments of the countries participating in the Stabilization and Association Process of South-East Europe have decided to cooperate on an interparliamentary level and follow the example given by the COSAC.

As you probably know, article 4.3 of COSAC's rules of procedure on observers, specialists and special guests states that: "The Presidency may invite observers from the embassies of the Member States of the European Union, and, after consulting the Presidential Troika, specialists and special guests".

The question of the interpretation of article 4.3 will be debated by the COSAC Chairpersons at their next meeting on 18 July in London. The UK Presidency will inform you on the outcome of that meeting.
