### SECTION 1: COSAC-related items including procedural issues.

- \* Evaluation of the way the COSAC is functioning (in order to report to the Speakers' Conference in Dublin). (B, Senaat)
- \* Which future role should the COSAC have? (Eur. Parliament)
- \* The COSAC-meeting ought to adopt a final resolution (As a resolution was adopted in London). (LUX, Deput.)
- \* Should the press have access to these working conferences. The House of Lords Communities Committee has now agreed on that issue. (UK)
- \* The COREU-P initiative on distributing of a shorter document every two months is preferable to anything more ambitious. (UK, H of L)
- \* Discussion of increased co-operation between specialized committees. (DK)
- \* Rules of Procedure of the Conference. (UK)

## Section 2: Organizational-related items

- \* Parliamentary scrutiny of the two Additional Pillars of the Treaty on the European Union. (UK, H of L)
- \* The question of Parliamentary scrutiny of the intergovernmental activity provided for under the Titles J and K of the Treaty on the European Union. (UK, H of C)
- \* Implementation of the proposal made at the Birmingham summit by Mr. Jacques Delors, President of the Commission, concerning the relations between the Commission and the national Parliaments.
  - A representative of the Commission, e.g. Commissioner, Mr. Joao Deus PINHEIRO should be invited for a further elaboration of this issue. (LUX, Deput.)
- \* Application of the principle of subsidiarity - control of all EC proposals and community law on the basis of the declaration of the European Council of Edinburgh.  
(D, Bundesrat)
- \* The principles of Openness and Subsidiarity. (DK)
- \* Perception of the Scandinavian countries' entry into the EC; specificity of these countries. (B, Senaat)
- \* Procedures in the EC-Member States for the nomination of the members of the Committee of Regions (D, Bundesrat)

Section 3 Proposals for initiatives of a substantial  
character.

- \* Initiatives concerning the Growth in the Economies. (Eur. Parliament)
- \* Strategical investment areas for future European economies  
- As strictly connected with the economic slump that, more or less, is affecting all the European countries, these items are on the floor in most national Parliaments. Therefore, we believe that the co-operation between community institutions and single States is of primary importance". (I, Deput.)
