Dear Colleague

We have pleasure in sending you the agenda for the 7th Conference of European Affairs Committees to be held in London on 10-11 November. This was adopted unanimously at the troika meeting on 12 October.

The troika meeting also agreed a number of points amplifying certain agenda items. Thus, on the first day, as part of item 3, delegations will be invited to draw to the attention of the Conference particular matters of concern in this area to citizens of their own countries; a number of these concerns will have surfaced in the course of the recent wide public debate in all Member States on the Maastricht Treaty. The discussion will also encompass the possible role of Conferences of the Parliaments. It is intended that this wide-ranging debate should occupy the bulk of the morning session.

Mr Tristan Garel-Jones MP, Minister of State at the Foreign and Commonwealth Office will be hosting a luncheon in honour of delegates at Lancaster House on 10 November. In the evening, there will be a reception for delegates at Speaker's House, House of Commons, to be jointly hosted by the Speaker of the House of Commons and the Lord Chancellor (as Speaker of the House of Lords), which will be followed by a dinner at a City restaurant, to be hosted by us. Delegates will receive their formal invitations to all social events when registering for the Conference.

On the second day, it is intended that the main discussion will be on item 1. It is intended that items 2 to 4 should be discussed only briefly - if there is a need for lengthy discussion of any of these topics, the Presidency will propose that it stands over to a future Conference. After a Communique has been adopted, we hope delegates will remain to join us for an informal buffet luncheon after the formal closure of the Conference.

This agenda has been drawn up so as to provide plentiful scope for both formal and informal exchanges, and thus build on the development of relations between the parliaments of the Community which this series of Conferences has so successfully fostered. We look forward to welcoming you all to London next month.
