1. FREQUENCY AND DATES OF MEETINGS

- 1.1. Ordinary meetings
- a) In favour of a meeting during the second half of the sixmonthly Presidency of the Council of Ministers are
- the Belgian Senate
- the Bundesrat
- Spain
- the French Assemblée Nationale
- the French Senate
- Greece
- Ireland
- Italy
- the House of Lords

whereas the House of Commons proposes that this decision should be a matter for the relevant Committee of the host Parliament because of financial implications.

- b) In favour of a meeting at a fixed date, at the beginning or at the end of the first week in May or November f. ex. are
- the Belgian Chambre des Représentants
- Denmark
- the Italian Senate
- Luxembourg

whereas the House of Commons states that this option would need to take account of different parliamentary practices of Member States, of election periods, of the dates of public holidays in Member States etc.

1.2. Extraordinary meetings

- a) In favour of the organization of a meeting if decided by an absolute majority of the Presidents of the European Affairs Committees and of the corresponding Committee of the European Parliament are

whereas the House of Commons stresses the fact that the questionnaire lacks a definition of the purpose of both ordinary and extraordinary meetings. It nevertheless prefers option a).

b) No delegation was in favour of the organization of a meeting if decided by an absolute majority of the delegation members of the European Affairs Committees of the national Parliaments and of the European Parliament.

The Belgian Chambre des Représentants proposes that this decision should be taken by the troika and the President of the Institutional Committee of the European Parliament.

1.3. Preparatory meetings

The Belgian Senate thinks that these preparatory meetings are to be replaced by telephone contacts and correspondance.

The House of Commons expresses the view that this decision should depend on who has responsibility for drawing up the agenda.

- b) Greece has chosen the option of an organization of a preparatory meeting if proposed by the host Parliament and if asked for by at least 5 parliamentary delegations and the European Parliament.
- c) In favour of the organization of a preparatory meeting if proposed by the presidential troika are

The House of Lords expresses the view that the preparatory meetings should be held by officials.

2. PLACE OF MEETINGS

All the delegations second the proposal that the meetings should take place in the Member State holding the presidency of the Council of Ministers.

The House of Commons however specifies that provision should be made for extraordinary meetings to take place elsewhere.

whereas the House of Commons recommends that only the European Parliament should be represented by 6 members.

Denmark expresses the view that the parliamentary representation of Member States with a monocameral parliamentary system should be reinforced by one or two members.

- c) In favour of the invitation of observers of embassies are

The Belgian Chambre des Représentants recommends to subject this proposal to negociation and proposes also to consider inviting observers of the Council of Ministers.

- d) In favour of the invitation of experts are

The French Assemblée Nationale also adopts this point of view if provided for by the preparatory meeting of the Presidents.

The Bundesrat proposes to invite observers and experts only in special cases.

The French Assemblée Nationale expresses the view that for some questions necessitating a common position it could be useful to plan a meeting of the specialized Committees of national Parliaments alone.

4.2. Extraordinary meetings

The House of Lords is in favour of doubling the national delegations and the delegation of the European Parliament.

In favour of a composition identical to that of ordinary meetings are

The House of Lords suggests the admission of observers of the EC Commission and experts if decided during the preparatory meeting.

5. CONVOCATION

All delegations are in favour of a convocation by the parliamentary Secretariat of the Member State holding the Presidency of the Council of Ministers.

The House of Commons states that special arrangements will be necessary if the meeting is held outside the territory of the Member State holding the Presidency.

The Belgian Chambre des Représentants proposes: Conference of European Affairs Committees of the European Communities' Parliaments.

The French Assemblée Nationale suggests introducing the initials CEAC (Conference of European Affairs Committees).

In favour of the name preceded by the chronological number and followed by date and place of the meeting are

The French Assemblée Nationale proposes to distinguish the CEAC by adding a Roman numeral.

Several Parliaments stress the fact that this designation should be reserved for Assizes meetings as of November 1990, namely

The Spanish delegation deliberately abstained from proposing any formula, thus marking the extraordinary character of this conference.

7. AGENDA

a) The Italian Senate is in favour of the drawing up of the agenda by the President of the European Affairs Committee of the host Member State or the two Committees, in case of a bicameral system.

The Belgian Chambre des Représentants also shares this view provided that the presidential troika and the European Parliament are consulted.

The House of Commons expresses the view that this task should be entrusted to the President of the host Committee, after consulting the troika, having regard to any suggestions put by other specialized Committees. The Conference itself should have the power to decide on the agenda of a subsequent conference.

The French Assemblée Nationale and the French Senate think that the drawing up of the agenda can be entrusted to the President of the European Affairs Committee of the host Parliament, if the Presidents of the European Affairs Committees were consulted in writing on the draft agenda, which will be definitely adopted during the preparatory meeting of the Presidents.

In order to stipulate the procedure of meetings participants should first of all agree on their subjects.

The following procedure could be taken into consideration.

- 1) The troika (+ President of the European Parliament Committee) proposes at the beginning of the semester one or several subjects drawn from the working programme of the Council of Ministers.
- 2) The national delegation of the Member State holding the next Presidency establishes the report(s).
- 3) This or these rapporteur(s) may request for the drawing up of his (their) report(s) the contributions of the other delegations.
- 4) The participating Parliaments will receive the reports (in French or in English and in the language of the author) at the end of March and September. They will assure themselves the translation into their national language.

In favour of a written contribution in French or in English are

In favour of a written contribution in both languages are

The Belgian Senate expresses the view that the oral as well as written use of all the languages of the European Communities should be permitted.

XXIX

The Belgian Chambre des Représentants proposes to modify the rules adopted by the Conference following the propositions of the Presidents of the European Affairs Committees addressed to the President of the host Committee. The modification must be adopted by the Conference on the basis of a report of the troika and the European Parliament.

The House of Lords grants the host Committee the initiative right. These revision propositions should be transmitted to the other European Affairs Committees at least 6 weeks before the next Conference. Each Committee must have the right to suggest amendments. These amendments should be transmitted to all the Committees by the host Committee, 2 weeks before their discussion. The final decision would be taken by the Presidents of the Committees by a qualified majority of 3/4.

The rules are to be adopted according to the mode of voting chosen for the adoption of its revision.
